

## LAUNCHING / BERTHING APPLICATION FORM 2010 FOR BOATS AND SAILBOARDS

The launch/berth fee for 2010 is £40.00 per boat (£25.00 for a member under the age of eighteen or a student in full time education) with a reduction of £10.00 for payment before the 31<sup>st</sup> January. Prompt payment helps the clubs finances and ensures the Race Officer list is completed before the start of sailing. Completed forms with fees should be handed or posted to the Club Managers, Elton Sailing Club, Elton Reservoir, Bury, BL8 2BR.

The organisers encompass everyone helping to run the clubs activities. The provision of safety boats does not relieve owners and participants of their responsibilities. I understand that Elton sailing club cannot accept liability for any injury, loss or damage sustained whilst taking part in activities.**

**As a participant, I accept the disclaimer of liability above, which removes my dependents and my own rights to claim compensation as stated above.**

**I also confirm that my dependents and I are competent to take part in these activities and that the boat/ sailboards to be used will have valid third party insurance of at least £3,000,000**
